

MAC Group – Privacy Policy (version 2 – Jun 2019)

The MAC Group are committed to maintaining the accuracy, confidentiality and security of your personal information. This Privacy Policy advises you how we collect, use and store the data that you provide to us. If you have any questions or concerns about this policy, please contact our Data Protection Officer on mail@macgroup.im

Our Legal basis for processing data: Data Processing is necessary for regulatory, contractual and for the purposes of legitimate, interests pursued by MAC Group. You have a right to object to any processing carried out on the basis of MAC's legitimate interests and this is explained further below.

What Personal data we may collect about you: MAC may collect "personal data" which shall mean any information relating to an identified or identifiable natural person ('Data Subject'); an identifiable person is one who can be identified, directly or indirectly, in particular by reference to an identification number or to one or more factors specific to his physical, physiological, mental, economic, cultural or social identity. Personal data may include - name, address, date of birth, contact details, NI number, residency, details on children / dependants, health, financial details and if required customer due diligence which may include certified copies of your passport / driving license or recent utility bill or other form of proof of address.

How MAC collect this information: MAC collect this information from either your employer or from you, during our meetings, email correspondence, telephone conversations, completion of facts finds or proposal forms. This can occur at any stage during our business relationship.

How we store your personal data: MAC hold your personal data in manual form in MAC's office on the Isle of Man and electronically on our Cloud based system which is hosted by SystemHost Ltd. The Cloud based system is only accessible by employees of MAC, who all have secure log in details. SystemHost Ltd are a UK firm and they have been ISO27001 accredited since 2005.

How your information will be used and who might we share it with: The information we collect will be passed to Providers of Financial Products and Services who are generally in the UK to enable them to process your request following our Financial / Commercial advice.

We may also share your data with other third parties e.g. –

- Greystone LLC (IOM) who assist MAC with invoice, income payment and audit processing
- Jacana Ltd (UK) who assist MAC with commission reconciliation
- UK & IOM Ombudsman & IOM Tax Office when required to comply with applicable laws and lawful government requests

Length of Data Retention: We will maintain records and data to comply with our statutory, legal and regulatory responsibilities as well as what we deem to be reasonable practice where there is no record keeping period set down in law or other rules. We will destroy client data in line with these retention periods and our commencement date for any retention period will normally be the end of the client relationship.

Erasure rights: You have the right to request erasure of your data if you feel that the data we hold is no longer necessary for the purposes for which you have provided it. MAC Group Shall remove data with undue delay unless there are compelling legitimate grounds for the retention which override the interests, rights and freedoms of the data subject or for the establishment, exercise or defence of legal claims e.g. when there is a Contractual or Regulatory requirement.
